## **Electronic Monitoring and Restriction of Liberty Orders**

**Angela Smith, Service Director G4S, Electronic Monitoring  
And**

**Quentin Fisher - Head of EM Community Justice Unit, Scottish Government.**

Angela commenced her career within electronic monitoring in 2002, when EM was rolled out nationally. She started as a part time field monitoring officer before progressing to full time roles within breach management and liaison. She remained in that role developing links with agencies within the Criminal and Youth justice systems until 2011 when she joined G4S. When G4S were awarded the electronic monitoring contract in 2012, Angela assumed the position of Service Director for the contract and has responsibility for all aspects including links with the Scottish Government, Criminal and Youth Justice Departments as well as all operational matters. Angela was also a member of the expert working group which was created by the Scottish Government in 2015 to look at the future uses of Electronic Monitoring in Scotland, resulting in the recommendations announced by Michael Mathieson in October 2016.

Quentin heads up the Electronic Monitoring Unit in the Community Justice Division. He has worked across a range of subject areas in the Scottish Government, primarily within the justice portfolio. He was previously the Head of the Criminal Justice Division and has also led teams responsible for the policy and legislation in respect of Human Trafficking as well as Alcohol and Civic Licensing. From 2006 to 2012, he was first the Senior Legal Advisor and later the Head of Policy and Development at the Office of the Scottish Charity Regulator. Prior to this, he was responsible for the development and implementation of the Charities and Trustee Investment (Scotland) Act 2005.
