## GUEST SPEAKER BIOGRAPHIES

**Deputy Chief Constable Iain Livingstone QPM** graduated in law from the Universities of Aberdeen and Strathclyde. He worked as a solicitor in Glasgow, Edinburgh and London before joining Lothian and Borders Police in 1992. Iain served in Edinburgh and West Lothian as a patrol officer and detective and at HQ as Head of CID and Assistant Chief Constable Crime. He has commanded many serious crime investigations and major events. He was appointed Deputy Chief Constable, Crime and Operations, for Police Scotland in 2012. In this role Iain headed national specialist policing capabilities, such as homicide, organised crime, counter terrorism, public protection, firearms and road policing. Iain has studied in New York as a Fulbright Scholar and undertaken external attachments to the Police Ombudsman for Northern Ireland as a senior investigator and to Her Majesty's Inspectorate of Constabulary. Working across the justice sector, he currently sits on the Scottish Sentencing Council and was a member of Lord Bonomy's review of corroboration. He was awarded the Queen's Police Medal and in May 2016 was appointed as Designated Deputy to the Chief Constable. Iain is currently in overall command of Police Scotland.

**Professor Sandy Cameron CBE** is a graduate of the Universities of Strathclyde and Aberdeen. In 1987, he was appointed Director of Social Work in Borders region where he remained until he was appointed Executive Director of Social Work Resources for South Lanarkshire Council in 1995. From there, he became Chair of the Parole Board for Scotland, a position he retired from in 2012. Professor Cameron is a past president of ADSW (the Association of Directors of Social Work), with which he has been closely involved through some of the most challenging times for Scotland's social work sector. He is currently a member of the National Advisory Body on Offender Management and the National Social Work Forum. He sits on the Lloyd TSB Foundation's Board of Trustees and is Chair of the Partnership Drugs Initiative Steering Group and a member of the Audit Committee. He is also a Director of Care Visions, Non-Executive Director of the State Hospitals Board for Scotland and Independent Chair of the Institute for Research and Innovation in Social Services (IRISS). He was appointed Chair of SASO in November 2016.

**Karyn McCluskey** worked in the police for 22 years in Sussex, Lancashire, West Mercia, Strathclyde and Police Scotland. She has just recently taken up the post of Chief Executive for Criminal Justice Scotland. She was Director of the Scottish Violence Reduction Unit for the last decade, which proposed a different way of addressing violence in Scotland. She helps support Medics Against Violence, a charity in Scotland, set up in conjunction with the Violence Reduction Unit. Karyn trained as a registered nurse, has a BSc and MSc in Psychology and is a fellow of the Faculty of Public Health. She received an Honorary Doctorate from the University of Glasgow for work on prevention of violence and an Honorary Masters from the Open University. She is an Honorary Lecturer at the University of Glasgow. She has worked in a variety of areas within the NHS, East Africa and HM Prisons. She has published work on Armed Robbery teams, Alcohol and Violence Interventions in a clinical setting and Violence Reduction. She is a board member of Simon Community Scotland tackling homelessness and is on the Board of the Scottish Professional Football League.

**Professor Niamh Nic Daeid** is Professor of Forensic Science and Director of Research at the Centre for Anatomy and Human Identification at the University of Dundee. Professor Nic Daeid graduated with a BSc in Chemistry and Mathematics from the Dublin Institute of Technology and Trinity College Dublin before going on to complete a PhD in bio inorganic chemistry from the Royal College of Surgeons of Ireland. She joined the University of Dundee in 2014 having worked at the University of Strathclyde for 20 years.

**Alison Di Rollo QC** was appointed Solicitor General for Scotland in 2016. She graduated with LLB and Dip LP from Glasgow University in 1983 and joined The Crown Office and Procurator Fiscal Service (COPFS) in 1985 following a legal traineeship in private practice, going on to perform front line prosecution duties in Dumfries, Edinburgh and Dunfermline, as well as a broad range of policy work in the COPFS Policy Group, before being appointed Deputy Head of the High Court Unit in Crown Office, and later Head of Operational Policy. In May 2008 she was seconded from COPFS to take up an appointment as a Trial Advocate Depute. In February 2010 Alison joined the COPFS National Sexual Crimes Unit. Between January 2013 and January 2015 Alison was the Head of the National Sexual Crimes Unit. From January 2015 until taking appointment as Solicitor General Alison was a Senior Advocate Depute.

**Professor David Wall** is Professor of Criminology at the Centre for Criminal Justice Studies in the School of Law at Leeds University where he researches and teaches cybercrime, identity crime, organised crime, policing and property crime. He has published widely and has been a member of various governmental working groups such as the Ministerial Working Group on Horizon Planning.

**Professor Kristel Beyens** is a sociologist and criminologist and Professor of Criminology and Penology at the Free University of Brussels. As Director of the research group on Crime and Society, Professor Beyens' research focusses on contemporary evolutions in punishment with special attention to penal decision making and the implementation of prison sentences and community punishment from a cultural, organisational and social point of view. She has published on prison overcrowding and penal policies, prison privatisation, penal decision making and sentence implementation, conditional release, work penalties, electronic monitoring and the transport of Belgian prisoners to a Dutch prison. She also conducts research on food in prison, the monitoring

officer as a new penal agent, digital prison, forced removal practices in immigration detention centres and recall to prison.

**Claire Lightowler** is Director of the Centre for Youth and Criminal Justice which works to improve children's lives through better policy, practice and knowledge related to what offending means or can look like in a criminal and youth justice context. She is passionate about ensuring that practitioners and children supported by the youth justice system have opportunities to share knowledge and influence strategic and policy decisions. She is currently doing research about co-production and women's community justice; user engagement and community justice; practitioner research and knowledge exchange.

**Stuart Allardyce** is Director of Stop It Now Scotland, the national programme for child sexual abuse prevention. He is chair of NOTA Scotland (National Organisation for the Treatment of Abusers) and chair of NOTA practice and policy sub-committee. Stuart is also an Associate at the Centre of Youth and Criminal Justice at Strathclyde University. A qualified social worker, he has worked with children and young people with harmful sexual behaviours as a practitioner, manager and trainer for over 16 years.

**Aaron Slater** is a service manager at SACRO with responsibility for Bright Choices (Honour-Based Violence) Fearless (Domestic Abuse) and Another Way (Commercial Sexual Exploitation). Aaron Slater has worked in the domestic abuse sector for the past 5 years, previously as the service manager for Abused Men in Scotland where he managed a national helpline and developed Scotland's first dedicated one to one support service for men experiencing domestic abuse. He is a Safe Lives accredited Domestic Abuse Service Manager and a trained Independent Domestic Abuse Advocate.

**Sheriff Seith Ireland** has been a Sheriff since 2003, firstly at Kilmarnock and now at Paisley Sheriff Court. He has served on the Council of the Sheriffs' Association and was Secretary and Treasurer for two years. Prior to his judicial appointment, he was in practice as a solicitor, mainly involved in criminal law. He served on the Council of the Law Society and convened the Society's work on what became The Scotland Act. Over the years in private practice and then on the Bench, he has served on bodies, both governmental and non-governmental, related to improvements in the delivery of criminal justice. He serves on the Scottish Board of Phoenix Futures, a charity dedicated to aiding recovery from addictions and is a member of the Council of SASO.

**Alyson Leslie** was once an Assistant Director of Social Work. She has worked as an interim manager and has chaired or participated in inquiries into the death or mistreatment of children. She has carried out many serious case reviews across the UK. In retirement, she is writing a history of UK inquiries and helping with a befriending project for released prisoners.

**Travelling from the South and Glasgow:** Join the M74 and take the M73, following signs for Stirling. Join the M80 following signs to Stirling. Take junction 6 signposted for Cumbernauld and Castlecary. At the roundabout take the first exit. At the next roundabout take the right-hand turn into St Andrews Drive.

**Travelling from Edinburgh:** Follow signs for the M9. Join the motorway and follow signs for Glasgow until you reach the Glasgow/Carlisle exit on the M876. The road joins the M80 towards Glasgow. Taking junction 6 signposted Cumbernauld and Castlecary, keep in the right-hand lane. At the traffic lights take a right. At the roundabout take the second exit and at the next roundabout take the right hand exit to St Andrews Drive.

**Travelling from Stirling:** Exit the M80 and take the exit towards Eastfield/Wardpark/Dullatur. Keep right at the fork, follow signs for Castlecary/B816. Turn right onto A8011. At Old Inns Roundabout, take the 2<sup>nd</sup> exit onto Eastfield Road. Turn left to stay on Eastfield Road. At the roundabout, take the 3<sup>rd</sup> exit onto St Andrews Drive and the hotel will be on your right.

**Travelling by Rail** (visit [www.thetrainline.com](http://www.thetrainline.com)) for rail tickets. The nearest train station is **Croy** – 5 miles. A complimentary transfer service from Croy Station to The Westerwood Hotel will be available for delegates attending conference. Cars marked “**Q-Hotels**” will be situated adjacent to the Ticket Office at Croy Station during the following times:-

Friday 3<sup>rd</sup> November – between the hours of 12.30 pm and 2.00 pm

Saturday 4<sup>th</sup> November – between the hours of 8.30 am and 9.30 am

Travellers from Glasgow should cross the railway bridge on arrival at Croy Station and proceed to the car park adjacent to the Ticket Office. Travellers from Edinburgh/Stirling/the east should walk through the Ticket Office and proceed to the car park. In the event there is no car awaiting the arrival of your train, please be patient. Travel time from the station to the hotel is approximately 5 minutes. Waiting times should be no longer than 10 minutes.
